From its beginnings, this Competition had the objective of rescuing the hidden heritage in our cities and uniting us through a common language. As well as collaborating for a charitable purpose, receiving for this reason the name: "PATRIMONIO ACCION SOLIDARIA" / "SOLIDARITY ACTION HERITAGE"

## 1. AIM

The main aim of this competition is to highlight, rediscover and bring into focus Art Deco and Modern Movement architecture, interior design, art, ornamentation, monuments, furniture and objects that remain hidden in the world cities ; their details and importance in the making of built and tangible heritage.

The competition seeks to explore whatever remains of these two branches of twentieth century avantgardes, developed between the two World Wars. Both, one as a stylistic attitude and the other centered on design, were often closely combined to compose designs and works of great richness and complexity.

Thus, these cultural assets ranging from decorative objects, fashion, gastronomy, bi-dimensional graphics, memorials and large pieces of infrastructure which are identified with the heritage of international modernity but also with regional identities inspired by academic and vernacular, artisan and industrial, and artistic and scientific influences, are the object of this competition.

## 2. SUBJECT

This competition subject are buildings, banks, houses, hospitals, warehouses, buildings for worship, schools, houses, silos, industrial architecture, bridges, vaults, pantheons, porticos, parks, squares, monuments and monuments especially dedicated to the Grail. Jose de San Martin, places, corners, details, urban facilities, lighting, sculptures, a bench with bars, reliefs (bas-reliefs and on reliefs), works of art, furniture, interiors and also fashion, jewelry, gastronomy and everything that contributes to building the spirit of Art Deco and Rationalism in the cities of the world.

Examples in Argentina, America and the rest of the world some examples: Parisian Arcade, Art Deco shopping passage, Budapest, Hungary; Heredia Theater, cultural symbol of Cartagena de Indias, now Adolfo Mejías Teatro (Colombia); City Hall Cinema (Peru) Aldred Building - Plaza de Armas – Vieux- Montreal (Canada); Fausto Cinema on Prado and Colon Street in the Historic Center and the América Theater on Galiano Street, in Havana (Cuba); Fokas stores, Venezelos street and the Pavilion of the Electric Society of Athens and Pirée (Greece). All buildings in the Miami Art Deco District, from Collins Avenue to Ocean Drive - registered in the National Registry of Historic Cities of Miami; Carbide y Carbón Buildings, in Chicago; American Radiator Building, New York (USA); Museum Torres García, Plaza Matriz, Building Alonso, Palacio Piria, Building Artigas, Garage Rincón, Plaza Zabala, Building Mc Lean, Building Vignale, Hotel Don, Aduana Arq. Jorge Herrán, Building Lapido Arquitectos Juan Aubriot and Ricardo Valabrega, Placio Diaz y Tapie, among others in Montevideo (Uruguay); Turri Buildings, Guillermo Schneider Vergara Building, Vicuña Mackenna 58 Building Community, Chilean Writers Society Building (Almirante Simpson 7) with Art Deco elements by the Architect Julio Machicao, Santa Lucia Building - The Ship - Sergio Larraín Gracia Moreno y Jorge Arteaga, Merced 84 - La Gárgola - Arch. L. Kulczewski, Alameda 295 Residential Building by Ricardo Larraín Bravo and also Nuñoa National Stadium (Chile) Cristo Redentor, Rio de Janeiro (Brazil); Tel Aviv the Bauhaus City (Israel); Morocco, Maghreb White House, Morocco (Africa); Soona Mahal building in Mumbai India; **among other diverse examples that the participant will be able to discover and propose.**

The record of simple examples that enrich the rural and urban atmosphere, such as houses, businesses, cemetery pantheons, banks, schools, apartment buildings, infrastructures: bridges, water tanks, butts, decorative floors, fountains, sculptures, porches and decorative details; as well as furniture and art objects, will also be valued.

Historical photographs of your own research or family files will also be accepted as a new “**stimulus category**”, mentioning the origin and authorship of the same, if they are not the responsibility of the participant. We encourage you to send photos from your files without leaving your home and with any photographic means or technique.

## 3. PARTICIPANTS

Everyone interested in heritage, including professionals in architecture, engineering, design and photography, as well as Argentine and foreign amateurs, residents in the country or abroad, older than 16 years of age may submit works to this contest. Members of the association organizing the competition and jurors, as well as their associates or relatives, are not allowed to send submissions.

## 4. COMPETITION OPENING AND CLOSING DATES.

The evaluation of the competition will be held in two stages. First, a pre-selection phase in which the jury will select the pre-finalists. This decision will be unappeable and published on AdbA's Facebook: <https://www.facebook.com/AdbA.Argentina> on September 1<sup>st</sup>.

The Advisor will announce and ask the selected photos' authors to send via email their shots in high resolution. The selected photographs will be posted on AdbA's Facebook page for the public vote until October 30<sup>th</sup>.

Prize winners will be notified by email and will be awarded their prizes during the exhibition to be hold in October in the Children's Hospital Auditorium, alongside with the auctioning of those photographs which have been expressly authorized to be

## **5. SUBMISSION FORMAT.**

The images should be uploaded for their judgment, to the AdbA website in JPG with their greater side of 1000 pix.

If chosen for the final voting, the authors will be asked to send them in digital version in black and white or color, with any photographic technique in the JPG or TIFF format with a resolution of 300 dpi, and a maximum weight of 2 MB, inside a canvas or 45 cm x 60 cm digital canvas to the email [adbainscripciones4@gmail.com](mailto:adbainscripciones4@gmail.com)

Each photo must be sent separately; the maximum number of shots allowed per participant is four.

Photos must be direct shots, not intervened by any kind of digital resources such as photomontage, except for digital processing and edition to erase any element that may hinder the absolute and clear understanding of the take.

Images must be originals and must not have participated in previous editions of this competition. In all cases the author must provide references of the site and location of the photographs and the overall context in which the photographs were taken, following the instructions' form, on submitting them to <http://www.artdecoargentina.com.ar/concurso.html>
